BIDDING IN THE AUCTION TOOK PLACE BETWEEN MAY, 2016 AND JANUARY, 2017. RCBC'S BID WAS FROZEN AND ULTIMATELY ACCEPTED WITH THE CONCLUSION OF THE AUCTION WITH THE BROADBAND PROVIDERS, AT \$71,979,802. RCBC WILL BE REQUIRED TO BEAR ALL THE COSTS OF MOVING TO THE NEW VHF ASSIGNMENT, CHANNEL 5, BY MAY OF 2020 AT WHICH TIME THE MULTIPLE BROADCAST CONVERSIONS, GENERATED BY THE AUCTION ACTIVITY, IS SCHEDULED TO BE COMPLETE. THE VAST MAJORITY OF THE PROCEEDS HAVE BEEN PLACED IN A QUASI-ENDOWMENT FOR THE SUPPORT OF RCBC IN PERPETUITY.
